3 Quality Management Details Lantal Textiles AG

Project Management	Lantal has defined management processes for all manufactured parts and products. The parts as well as product management process is described in our EN 9100 quality management handbook. Management of project deliverables are summarized in our quality management handbook.
Supply Chain Activities	Lantal supply chain management processes are documented in <ul style="list-style-type: none"> – supply chain network – supply chain optimization – supplier management – production procurement planning – material resource planning
Validation	All Lantal parts and products go through a defined Quality Gate procedure where production serial records are generated, including reference samples disposition. The validation of new products will be handled case by case, or also in real tests. These processes are fixed in our Design and Develop Manuals. Parts and products are internally released and can be accompanied with an EASA Form 1, certification of conformity and/or test results documentation. Variations i.e. Non-Conformance Reports will be tracked by 8D step-reporting form.
Compliance	Lantal creates test plans for each part or product, which are in accordance with design specifications and requirements. All test results are archived for minimum of 13 years.
Change Management of QM documents	Lantal change management processes are defined in the quality manual handbook and in the production organisation manual 2.4.
Procurement	Lantal prefers long term supplier agreements and monitor their operational performance regarding quality and on time delivery. Suppliers are evaluated on a regular base concern hard and soft facts which results in a supplier categorisation of A, B or C suppliers.
Testing / Analysis	Fire protection requirements in aircraft and railed vehicles: Fire tests for interior materials and components are conducted in Lantal's in-house laboratory which is accredited in accordance to ISO 17025.
